THE SECRET SAUCE OF COMPLIANCE

What is your secret sauce for compliance? I don't know that it is a secret sauce, but there is something quite special about making an ethics and compliance program come alive to your employees. It can be a rather bland topic, so making it fun, lighthearted and not too serious will get you more airtime than images of handcuffs and information about potential penalties.

Our job as ethics and compliance professionals is to make the program relevant to each person's "why I get up in the morning" and that's the special sauce!

How have you and your team adapted to the change in working arrangements?

How do you make sure that compliance stays relevant at **Panasonic Avionics?**

That is the ultimate challenge! We have managed to do this in a couple of ways, but most importantly, by listening to the business and adapting where they need us the most.

I absolutely despise this question! All of it and none of it. You always need to keep your eyes open; trying to point to one specific item would be the death knell of any compliance professional.

You've got to have some inherent trust in your business ... then pressure test that trust with data and risk assessments.

Overall, quite well. We are located all over the world, so we had been operating in a virtual environment to stay connected. One game changer has been our use of Microsoft Teams. With managing multiple time zones, it allows us to post chats and collaboratively work on files without the constant "ding" of email notifications. I absolutely look forward to getting back on the road and having those in-person connections!

What do CCOs need more of?

Risk tolerance. The ethics and compliance function exists to support the business, not the other way around.

Getting outdoors every day, even if only for a few minutes. It's amazing what sunshine and oxygen can do for one's sanity.

What would you say to someone considering a career in compliance?
